Terms and conditions:

- 1. Consumables are to be brought by user or will be charged on case to case basis as per the rate fixed by ICAR-NIFMD, if agreed mutually.
- 2. Other laboratory/ workshop/ analytical facilities will be charged on case to case basis and as per the charges fixed by the ICAR-NIFMD.
- 3. The rate quoted above is exclusive of taxes. The tax will be charged as per rule.
- 4. Per day means up to 08 hours working period.
- 5. Rentals can be paid through payment gateway /DD in favour of *ICAR unit PDFMD*, *Jatni*. Following details may be used for online banking:

- 6. Rental should be paid in advance or latest by 7th of the starting month, after which interest @ 2.5% will be levied per day.
- 7. Long term user need to be submit security money @6% of total value of hiring cost and it will refunded after successful completion of hiring tenure.
- 8. Operational or any other charges to be paid as per the norms.
- 9. Before the hiring the facilities/ equipments, a MoU will be signed between users and ICAR-NIFMD.
- 10. Total number of person to be accommodated will be discretion of institute.
- 11. Capacity building program followed by screening/ evaluation of participants by a committee designed by institute will be done and qualified participant will be allowed to work in BSL-2 & BSL-3+Ag facilities.
- 12. The users strictly adhere to the SOPs of facilities/ equipments.
- 13. Confidentiality agreement has to be signed by the user before hiring the facilities/equipments.
- 14. All the critical equipments will have to be used with the help of facilitator.
- 15. Any change in standard setting of operation of any equipment required by the users must be carried with prior permission to incharge of the equipment.
- 16. Fine to be levied towards any damage caused by the user to ICAR-NIFMD properties as decided by the Competent Authority of the Institute.
- 17. User should provide detail medical fitness certificate.
- 18. Normal health and safety standards are to be observed and maintained within the premises of NIFMD, as prescribed by the In-charge, Bio-safety Officer of the Institute. No hazardous material can be brought inside the premises without prior approval of the authorities.
- 19. The officers of this Institute shall be allowed access to visit and inspect the office space, any other facilities rented out to user as and when required.
- 20. No legal, financial or criminal liability shall arise for commission of any act or omission thereof in respect of any accident or injury to any workman or any other person employed and ICAR-NIFMD stands indemnified against any claims, damages or proceedings of any manner.

- 21. The mentorship/guidance of scientific, technical, or commercial nature shall be chargeable if availed. No services shall be rendered without the applicable fees either pre-assigned or fixed on case to case basis. The Director, ICAR-NIFMD is the final authority to fix or re-assign the fee for various services available.
- 22. Not with standing any issue pending between the user and the Institute, the user shall have to vacate the premises on the notice of vacation or completion of the agreed term of incubation.
- 23. The user shall have to follow all the rules and/or guidelines prescribed and/or modified from time to time by the Institute. For any unprecedented issues, the available rules of NIFMD shall be applicable and the Director shall have full authority to form/ amend all/ any of the guidelines/ rules.
- 24. Foreign Visitors: user shall be required to inform and take permission from the Institute about any visitors from abroad, foreign collaboration and/ or foreign partner and shall abide by the rules/ procedures of ICAR/DARE/GoI.
- 25. No material shall be allowed to be taken out of the premises of the ICAR-NIFMD without prior written permission of the authorities.
